Gujarat Infrastructure Development Board (GIDB) is Nodal agency for Gati Shakti Gujarat Integrated Master Plan and Gujarat Integrated Logistics & Logistics Parks Policy 2021 for the State and GIDB is also the Coordinating body for development of projects taken up under the Delhi Mumbai Industrial Corridor (DMIC).

Whereas, it has been deemed necessary to revise the order of appointment of Nodal Officer.
