### **Preface**

With the objective of improving freight performances of the State and aligning with the Draft National Logistics Policy, the Gujarat Integrated Logistics & Logistics Parks Policy, 2021 was released by Industries & Mines Department on 17th July, 2021.

Gujarat was ranked the highest in the Logistics Ease Across Different States (LEADS) index published by DPIIT consecutively for the three times for the years 2018, 2019 and 2021 and also ranked in the "Achiever" category which is the highest category in ranking of LEADS in the years 2022 and 2023. The index aims at enhancing the focus on improving logistics performance across states which is essential for improving the country's trade and reducing transactions cost.

#### Preamble

The Government of Gujarat, to further strengthen Gujarat's Position in the Logistics and improving Logistics Sector Performance and Efficiency in Gujarat, hereby resolve following:

#### Resolution

The State Government is pleased to constitute the following Committees for improving Logistics Sector Performance and Efficiency and Implementation of Gujarat Unified Logistics Interface Platform with the detailed composition and functions as below:

### 1) Logistics Core Committee:

#### A. Logistics Core Committee shall be as under:

# C. Roles and Responsibilities of Logistics Core Committee:

a. Identify infrastructure gaps in existing Logistics Facilities, policy framework, technological and support system, multimodal integration and logistics inefficiency, finance and investment deficit, among others.

- b. Formulate strategies to fill up the gaps through capacity creation (green field) and capacity augmentation (brown field), efficiency enhancement, policy formulation etc, directed towards reducing the logistics cost with an aim to achieve multi-modal and last-mile connectivity.
- c. Prepare sector specific logistics plan (including domestic and EXIM trade).
- d. Identify suitable locations for development of Multimodal Logistics Parks, Freight Terminals, Freight Nodes, First & Last-mile connectivity issues and other Freight infrastructures requirements for ease of logistics movements for domestic as well as EXIM Freight traffic
- e. Suggest modifications/ improvements in the Gujarat Integrated Logistics and Logistics Parks Policy, 2021 and other policy frameworks.
- f. Identify and develop strategies for first mile and last mile connectivity bottlenecks for Western DFCC, Pórts, Airports and Industrial Estates.
- g. Identify infrastructure bottlenecks and missing links and first mile and last mile infrastructure connectivity for improving logistics performance.
- h. Take necessary steps for creation of a database of industrial and cargo movement and Freight movement pattern in Gujarat.
- Suggest logistics related key performance indicators (KPIs) for monitoring the logistics performance, including logistics dashboard and logistics data analytics.
- Adoption of PM Gati Shakti Gujarat for project planning and implementation and Inter-agency coordination.
- k. Any other tasks/ directions issued by the State Logistics Coordination Committee and also submit regular status updates to State Logistics Coordination Committee.
